- 6. BUYER agrees to have puppy examined by a veterinarian within 72 hours of delivery. IF, after examination by a licensed veterinarian, the puppy is determined to be IN POOR HEALTH OR HAS A CONGENITAL DEFECT, puppy MAY BE RETURNED to the BREEDER WITH A WRITTEN REPORT FROM THE VETERINARIAN. IF THE PUPPY IS RETURNED DUE TO A CONGENITAL DEFECT WITHIN THE 72 HOUR TIME FRAME, THE BUYER WILL BE ISSUED A FULL REFUND. IF BEING RETURNED DUE TO POOR HEALTH, A REFUND WILL BE CONSIDERED DEPENDING ON THE CAUSE OF POOR HEALTH IF IT IS LIFE THREATENING. SELLER WILL NOT BE RESPONSIBLE FOR Coccidiosis or Guardia, which can be acquired at any point, once the puppy has left the care of Seller. After the exam, the BUYER MUST send a copy of the exam via mail or email to the BREEDER. Failure to provide nullifies and forfeits the Return/Refund Agreement.
- 7. BUYER recognizes that the puppy is a living entity with assumed risks, potential hazards, injuries and fatalities and agrees this puppy is sold with no guarantee against life threatening issues and/or hereditary genetic diseases. At the time of this contract, the BREEDER tests for and guarantees that the puppy will not be At Risk for DM, VWD1 and EIC. The BUYER agrees that they fully understand once this puppy has left the care, custody and control of the BREEDER that the Buyer assumes full and total responsibility for this animal. The BREEDER is NOT responsible for any diseases or illnesses once the puppy leaves their care, as there are too many environmental factors out of their control, as well as many unknown, untestable and unpreventable diseases with unknown causes to ensure perfect health. At NO time will the BREEDER be responsible for any vet fees incurred by the BUYER. BUYER also recognizes, acknowledges and accepts, it is beyond the scope of the SELLER to guarantee a "perfect" outcome throughout the dog's life and BUYER releases SELLER from any responsibility or unrealistic expectation of future outcome with said dog, including issues with disposition.
- 8. BUYER is aware that a puppy is a baby that is leaving our home and entering a new environment. Stress related sicknesses may occur. We do due diligence for a happy, healthy puppy. Proper care is a must. BUYER agrees to provide quality food, water, shelter, training, social interaction, exercise, companionship, love, and

veterinarian care for the life of the canine or the duration of time while it is in their care. The BREEDER suggests that the BUYER consider pet insurance, but does not require it.
